### EXPERIENCE

Eveline Trines has over 26 years of working experience in over 30 developing countries, working in natural resource management, sustainable forest management, project development, management, monitoring, evaluation and certification, standard development, and providing advice on Environmental, Social and Governance (ESG) issues to the private sector. She has spent significant quantities of her professional life in Africa, Latin America and SE Asia. From 1997-2012 the prime focus of her work was on climate change in combination with forestry, land use, community issues and biodiversity. She has worked for the UNFCCC secretariat, UN-REDD, FCPF, World Bank, the FAO, GIZ/SPC, the IPCC, nature conservation agencies (e.g. IUCN, CI, Ramsar), various Dutch Ministries (Foreign Affairs, Environment and Agriculture&Nature), the European Community (EC), forestry companies, environmental and consultancy agencies (Swedish Environmental Protection Agency, Winrock International, etc), international certification bodies including the Verified Carbon Standard (VCS), private sector entities (TNT, Danone), conducted due diligence work, designed and audited forestry companies and projects, provided strategic business advice on CSR to multi-nationals; and, worked for science/research institutes (IPCC). Since 2012 her attention shifted towards Corporate Social Responsibility and ESG issues, in particular related to Natural Capital, greening value chains, and the push for Net Positive Impact (NPI) on biodiversity.

From the 26 years of working experience Eveline has spent 12 years abroad whilst working for various organisations, and ran her own companies for 13 years before she joined the Dutch Committee of the International Union for Conservation of Nature (IUCN) in October 2014 until the end of 2016, working as Team Leader Business Engagement and Senior Advisor Natural Capital and Value Chains.

Eveline has now resumed her career as independent expert. She was the co-founder of Scope14<sup>+</sup> (previously known as "Treeness Consult"; founded 2002) and the Metta Standard and Index Foundation (founded in 2013); and, before that of Silvestrum VoF ('08-'12).

Eveline Trines holds a Master's Degree in Environmental Forestry with honours and has been awarded a certificate for her contribution to the award of the Nobel Peace Prize 2007.
